





### AZ Dental Therapist Licensing Begins in July!

It's been a long time coming. Since the summer of **2020**, Arizona State Board of Dental Examiners (BODEX) members and stakeholders, including AzDHA, have been working to draft administrative rules to fully implement the dental therapy law that went into effect in **2018**. The Arizona Board of Dental Examiners (BODEX) finally filed its Notice of Final Rulemaking for dental therapy with an effective date of **July 10**, **2023**, at which time, dental therapists may apply for an AZ license.

### We Are Still Waiting for the End of the 2023 Legislative Session!

Our hopes that the AZ Legislature would conclude its business and adjourn sine die by the end of June have been dashed! They now stand adjourned until Monday, July 31st. The issues that have delayed the end are still in play, however, they are expected to come back to limited activity and adjourn sine die shortly thereafter. This historically long session is meaningful because absent an emergency clause, legislation that has passed & signed by the governor, including our scope of practice bill, HB2473, cannot go into effect until 90 days after sine die. It appears that at best, our new scope of practice will not be in effect until November.
